# "Understanding Europe" Regulatory policy in the EU



The Albert Ludwigs University in Freiburg/Breisgau

At our Young Professionals Seminar in Freiburg, we will focus on the question, how policy in the EU works: How laws are made in Europe, how contracts come into being and about the importance of a functioning regulatory policy. The workshop takes place in cooperation with the Wilfried-Guth-Stiftungsprofessur für Ordnungs- und Wettbewerbspolitik (co-organiser) and the Centre for European Policy (CEP) in the Albert Ludwigs University in Freiburg.

The **CEP** systematically and continuously accompanies the economically relevant projects of the EU and monitors European legislative procedures in the European Parliament and the Council. It provides the wider public with up-to-date information and comprehensive background knowledge about policy proposals of the EU, evaluates EU proposals based on modern, liberal, market-based ordoeconomics – before they are adopted, highlights economic and legal consequences, drafts practicable policy options for Europe, and contributes to greater transparency of the democratic decision-making process in the EU. In Freiburg, we will bring together 24 outstanding young professionals from across Europe, representing a wide array of professional backgrounds, to discuss these questions.

state law exam in 2003. He is the EPP Group Coordinator in the Committee on the Internal Market and Consumer Protection, a substitute Member of the Committee on Economic and Monetary Affairs, a member of the Bureau of the EPP Group as well as Chairman of the CDU Südbaden.

	The key to understand the EU lies in understanding its institutional structures and its decision-making processes. In this seminar we will therefore take a closer look at the main EU institutions, in particular the Parliament, the Council and the Commission. We will define their tasks, identify the institutional interests arising from their respective composition, explore the internal structures of the institutions, analyze the inter-institutional relations and discuss potential reforms. The seminar will also shed some light on the opaque process of adopting primary and secondary EU legislation. We will analyze the various stages of the law-making process, from the Commission's proposal to the trialogue, consider the role of national parliaments and explore the relevance of comitology.

9:00 **Seminar II: The Euro-crisis** 

Workshop trainer: Dr. Matthias Kullas. CEP

Seven years after the banking and sovereign debt crisis turned into an economic crisis, the Eurozone as a whole looks healthy and stable: The economy is recovering and showing remarkable rates of growth. The fears that parties hostile to Europe and the euro could come into power in France, Germany and the Netherlands, did not materialise.

Despite this positive news, the EU Commission still sees a need for reform in the Eurozone. The EU Commission has correctly recognised that, in spite of the positive headlines, the Eurozone must be further stabilised because there is still a lack of convergence between the Eurozone countries, which is essential for reducing the pressures in the Eurozone. Greece, France and Italy, for example, have already been showing below average or even negative GDP growth rates for several years.

Against this background, this seminar will analyse the roots of the Euro-crisis. Moreover, we will discuss the measures that have been taken to overcome the crisis. Finally, we will discuss the current state of the Eurozone.

11.00 Seminar III: EU Energy and Climate Policy: Features and Conflicts
Workshop trainer: Dr. Götz Reichert, CEP

The search of European states for common solutions to energy issues has been a major impetus for European integration since the early 1950s. Today, ensuring a secure energy supply at affordable prices while at the same time reducing CO<sub>2</sub> emissions are the key challenges of the European energy and climate change policy. To this end, the European Union aims at creating an internal energy market, promoting energy efficiency, supporting renewable energies and interconnecting energy networks across borders. Various EU instruments – ranging from standards for energy-efficient products



to the EU Emissions Trading Scheme – are substantially shaping the national policies of the EU Member States. The recent policy reforms, which have been the subject of fierce debates in Brussels, have revealed the different interests of Member States, businesses and environmentalists. Against this background, the seminar will present the essential features and conflicts of today's EU energy and climate policy.

### 13:30 **Seminar IV: Quo vadis, Britain?**

Workshop trainer: Dr. Bert Van Roosebeke, CEP

For the first time in history, a Member State has decided to leave the European Union. Following the Brexit-Referendum, the United Kingdom will be leaving the European Union at the end of March 2019. This confronts both the EU and the UK with unprecedented legal, economic and political challenges.

This seminar will demonstrate the economic impact of Brexit and will – as far as possible – provide clarity in the Brexit-Chaos. We will discuss the sequence of the negotiation process and the importance and difficulties of the transition phase in Brexit. In addition, we will discuss the possible nature of the future, permanent relations between the EU and UK (as a third country, i.e. not member of the EU). We will assess whether the European Economic Area, the Ukraine-treaty, the EU-Switzerland treaties or a CETA-like trade agreement can proof as an example to future EU/UK-Relations.
